I am notifying the court that I do not live at the address where Neil McCabe, from O'Quinn Law Firm is attempting to service me at 2601 Summit View, Bedford, TX 76021 and Mr. McCabe is fully aware that I do not reside at this address. I have not lived there since Oct of 2006. The O'Quinn Law Firm has been illegally interfering in my privacy, torturing myself, my mother and more since at least August 2007 in attempts to financially destroy me and silence my freedom of speech.

It began at Shenandoah Apartments in Bedford, TX and O'Quinn's law firm and/or its representatives began harassing me. They created their own electric company, cyber terrorism [illegally accessing my computer] etc. to ensure financial destruction; the electric company Electric Now, PO BOX 4438 MSC #300 Houston, TX 77210 [www.electriconow.com] that would charge me 2-3 times more than necessary. Sarah Sinclair from the apartments as "new management" suddenly took over and eviction proceedings instigated. They then had a landlord by the name of Eric Blanco, rent me a home with no heat and cause major disruption in my life, including my neighbor 'Vivian' who was from Houston to keep an eye on everything I did. I could continue with daily criminal activity, but I will leave it at that for the time being as evidence disappears fast.

As of yesterday, I became aware that my computer, that McCabe is seeking information from, has been breached/tampered with, in a safe deposit box, in Bank of America on Bedford-Eules Road in Hurst, TX, I can now understand why such extreme measures were taken by both the Hurst Police Department and CPS to have me committed and take my children away from me as I tried to get to my computer Wed./Thurs. to file an insurance claim. The bank changed their vault door locks last week AND the customer service representative has been gone for past few weeks since I realized that bank documentation was missing; I was unaware that they had breached the actual safe deposit box until yesterday. I am unable to access my own computer at this time which is NOT the condition I placed it in the safe deposit box. I have an FBI Cyber Terrorism Complaint #10803150238302161 since March 2008. There are multiple complaints filed in Hurst and Ft. Worth police departments regarding stolen documentation, computer parts, harassment etc.

Neil McCabe neglected to send a certified letter, as he did with other defendant Bonnie Stern, or he would have known I was not living at that address. Again, my mother has been in contact with a representative from their firm at 8613 Brushy Creek Trail, Ft. Worth, TX 76118 where I have lived since March, 2008. My address has been PUBLIC information from the Texas - Tarrant County Civil Courts since October 2007 which is also easily accessible to any CAPABLE attorney and/or its representatives.
